### **Food Vendor Requirements/Information:**

Provide a self-contained trailer

Food Handler's license is mandatory. Submit a copy with Vendor application.

You cannot sell beverages containing alcohol.

Provide a list of merchandise items for sale. Zavala approval is required.

**Electricity is not guaranteed.** Please bring your own power source.

### **Specialty Vendor Requirements/Information:**

Provide a professional setup with signage, tents, or trailer.

Specialty Vendor cannot sell any food or beverages of any kind. (Water/drinks can be brought for "personal use only.")

Contact Zavala if you need electricity—it is NOT guaranteed. Vendor needs to furnish a 100 foot-long heavy duty extension cord.

### **Non-Profits:**

Provide a professional setup with signage, tents, or trailer.

Each Non-profit will receive a **10' x 10'** space

Contact Zavala if you need electricity—it is NOT guaranteed. Vendor needs to furnish a 100 foot-long heavy duty extension cord.
